V.1 Introduction

This Appendix provides an update to the Appendix V from the Draft DRECP on details of government-to-government consultation, coordination, and outreach for the DRECP Proposed LUPA and Final EIS. The extensive summary and list provided here has been updated to include substantial outreach that has occurred since the Draft DRECP and EIR/EIS was released, but the summary is likely not an exhaustive list. Please refer also to Volumes III, IV, and V of Proposed LUPA and Final EIS document for other information relevant to the government-to-government consultation process:

- Volume III: Chapter III.8 (Cultural Resources) and Chapter III.9 (Native American Concerns) – Description of the affected environment and regulatory setting

V.2 Summary

Government-to-government consultation was initiated in 2011 by the Department of the Interior and several agencies within the Department for the DRECP under Executive Order 13175, “Consultation and Coordination with Indian Tribal Governments” (*Federal Register*, Volume 65, pages 67249-67252, Nov. 9, 2000). A record of consultation, coordination and outreach, that occurred prior to release of the Draft DRECP from 2011-through October 2013 is available in Appendix V-1, Table 1 of the DEIS.

There are over 40 Federally recognized tribes identified in the planning area and participating in varying degrees in the consultation, coordination, and outreach process through meetings, correspondence, phone conversations, e-mails, and the transmission of maps, documents, and reports.

Through the Tribal Federal Leadership Conference (TLC), the Department of the Interior and the Bureau of Land Management, with the participation of the Fish and Wildlife Service and the Bureau of Indian Affairs at some meetings, specifically solicited and facilitated tribal input in to renewable energy land use planning in the California Desert Conservation Area Plan (CDCA). The CDCA is proposed to be amended as part of the DRECP. The Tribal-Federal Leadership Conference (TLC or Conference) represented substantial regional outreach and information

sharing via numerous TLC meetings (9/21-22/11, 11/16/11, 2/16/12, 4/3-4/12, 7/18/12,12/12/12, 2/4/14, 5/5/14, 12/11/14, and 9/23/15), 1 pre-meeting, numerous technical meetings, and individual meetings with 40 California Desert area tribes, The Conference also provided information, maps, technical assistance, presentations, access to executive level federal management, funding sources and specialized services. The goals of the Conference were to solicit/facilitate tribal input into DRECP and inform future planning in the area about tribal issues, concerns, interests regarding any and all natural and cultural resources in the California Desert area – not just cultural issues and concerns. Through this the BLM received a deeper understanding of tribal concerns and valuable input as to those areas that are highly significant that will help BLM manage in a more informed and fair manner. BLM provided technical support to those Tribes that requested it for mapping the areas they defined as significant for DRECP. In 2014, the State joined the Conference meetings.

The BLM has met with most of the Federally recognized tribes in face-to-face meetings and has also contacted other potential consulting parties. The outreach to date has led to the exchange of information and discussion of concerns that have shaped the development of the DRECP. Consultation between the BLM, tribes, and other consulting parties is ongoing and will continue to take place after the release of the Final DRECP.
